**First Presbyterian Church** - Ongoing feasibility study and design proposal for existing church building / campus and possible future expansion. Selected to be part of churches vision / planning committee. Ipswich, MA. 2009 - present ( Studio Kline )

**15 Walnut** - Expansion / renovation of restaurant to double size of bar and dining areas. Coordinated design and all drawings with owners, engineers, general and sub-contractors and town building./ zoning department through to project's completion. S. Produced 3d-modelled sun/shade study and performed complete energy code analysis of proposed design. Project required Conservation Commission and Zoning Board approval.
